

**HUNTERS RIDGE GOLF AND COUNTRY CLUB  
SOCIAL COMMITTEE MINUTES  
WEDNESDAY, MARCH 26, 2014**

The meeting was called to order at 4:00 PM by the Co-chairman, John Simoncini.

Members present: Jacqueline Gannucci, Sydell Nusbaum, Al Perrotta, and Dave Miller, the Co-chairman and Hunters Ridge Board of Director's liaison.

Absent: Suzanne Evans McMurtrie, who was out of town due to business.

Kim Young, Food and Beverage Manager was also in attendance, as was Hunters Ridge resident, Rose Romero.

The minutes of the December 9, 2013 meeting were approved as read. They were also posted on-line in December.

**OLD BUSINESS:**

The events of January 2014 up until the present time were discussed.

January – Pat King, Country-Western, and Uptown Express, Dinner Dance were both well attended.

February – Johnny T, Karaoke, Jerry Dycke, Valentine's Day (Hearts and Flowers) and The Initials, Dinner Dance were well attended.

March – Renata and Paul, Men's Member Guest, Craig and Claudia, St. Patrick's Day, Nevada Smith and Mark, Women's Member Guest were well attended.

**SUGGESTIONS:** Uptown Express should be an outside/patio event. For the upcoming season, we should schedule them later in the year so that the weather would be more conducive for an outside event. It was decided, regardless of the contractual constraints, musical events on Pub Night should be from 7PM-9PM. Next season St. Valentine's Day should be a non-musical event. We should discuss further if we should cancel music for St. Patrick's Day as well.

We discussed trying to strictly adhere to the past survey of no music on Pub Nights. We have to consider the wishes of the residents as well as the availability of the entertainers. An appropriate balance will continue to be our priority.

We will also distribute our own survey specifying musical entertainers, types of entertainment, genre of the musical events, and comments at our Aloha Party. We will use those results for future events.

## **NEW BUSINESS:**

There were not any new members to introduce. However, Ms. Rose Romero did express a desire to be on the committee. Dave Miller will discuss with Fred Forbes, President of the Board.

We added an additional Karaoke night with Tommy T. due to popular demand on Thursday, April 24, 2014.

We discussed musical events for one Thursday a month during the months of May through August. The following entertainers are scheduled: Pearl and Sase, Nevada Smith and Mark, Laurie Saunders, and additional performers are being sought.

We discussed at length the terminology of: Special Pub Night, Regular Pub Night with Music, etc. to alleviate reservation issues, ½ price drink concerns, timing of the music vs. timing of the dinner. This will be discussed at future meetings.

Manhattan Connection is not available for New Year's Eve, December 31, 2014. We did book them for December 31, 2015.

We would like to book a national group in the future, but they are expensive. However, we could "cut down" on events to assure we have the finances in our budget to allow that booking.

## **SUGGESTIONS/COMMENTS.**

Could we revisit a movie on the green? Possibly, Suzanne Evans could research this event.

Could we consider an event at the pool for the month of September with the possibility of a Steel Band and a \$1 beer night?

Could we schedule an event in March 2015 on a Tuesday night instead of a Thursday or a Saturday Dinner Dance?

John Simoncini explained that sometimes time is of the essence as to scheduling an entertainer ASAP. He has had to do this in the past, but will email the committee with that information to keep us apprised.

Sydell Nusbaum offered an update on the following:

Fashion Show, March 7, 2014 was considered a huge success, and we will do this again in 2015. It raised more money than in the past.

Broadway Palm did not sell all the tickets. We should not consider this for 2015.

Trivia and Bingo attracts a large attendance. It will be scheduled through April. Name That Tune had low attendance. These events will be available next September or possibly January.

Our next meeting is scheduled for Monday, April 28<sup>th</sup> at 4PM.
