Social Committee Minutes

Wednesday, April 27, 2011

### **NEW BUSINESS:**

The subject of continuing the hiring of national acts and scheduling Dinner and A Show for 2012 was discussed at length. Don Huprich broached the subject of the economy, the high price of gasoline, the rising cost of food, and the fuel surcharges that the club is experiencing and other financial constraints which may hinder our ability to continue hiring these costly acts. We must be conservative! Don Huprich will investigate this

situation. Our ability to hire National Acts was also discussed. Don Huprich was adamant that we will not use Barry Newman or Michele Newman as agents for these acts. He will investigate other talent agencies.
